9.a For Possible Action: Discussion and possible action regarding an amendment to a final subdivision map known as Emerson Cottages (SUB-2020-0212) to change the lot lines between common area 1 (Assessor's Parcel Number ("APN") 002-781-10) and APN 002-781-11 and common area 2 (APN 002-781-12) and APN 002-781-11, located on the east side of Emerson Drive, immediately south of I-580. (Heather Ferris, hferris@carson.org)

Staff Summary: The Board of Supervisors ("Board") granted approval of the Tentative Subdivision map for Emerson Cottages on August 20, 2020. The Final Subdivision map was approved by the Board and recorded on May 20, 2021. Paradiso Emerson CC, LLC ("Applicant") is now seeking an amendment to the map to reduce the sizes of

common area 1 and common area 2 resulting in the NV Energy parcel, APN 002-781-11 (not a part of the original map), becoming larger in size. The portion of the common area parcels that will be included in the NV Energy parcel are currently landscaped and maintained by NV Energy via an easement. The amendment will result in the ownership of the property matching the maintenance responsibility. Nevada Revised Statute ("NRS") 278.477 requires an amendment of a recorded subdivision map to follow the same procedures for approval and filing of the original final map. NRS 354.290 requires the County Auditor to report to the Board of Supervisors a statement of revenues and expenditures based on the accounts and funds as were used in the budget. Staff Summary: The interlocal agreement authorizes DHCFP and DWSS to provide the administrative services necessary to implement the Nevada Medicaid Program State Plan in Carson City and requires Carson City to pay the non-federal share of Medicaid expenditures to DHCFP for medical, administrative and transaction costs for individuals qualifying for Medicaid in Carson City. Carson City's payment of the not to exceed amount of \$5,854,848.90 is supported by an ad valorem tax of 8 cents on each \$100 of assessed valuation of all taxable property in Carson City. Staff Summary: During the 2019 Legislative Session, the Nevada Legislature enacted Assembly Bill ("AB") 301, which requires the Sheriff to submit to the Board of Supervisors ("Board") a biannual report containing aggregated data similar to the information required to be submitted pursuant to the federal Death in Custody Reporting Act of 2013, Public Law 113-242, concerning the deaths of prisoners in the jail during the immediately preceding six months and the circumstances surrounding any such deaths. AB 301 also requires the Board, at least twice each year, to include as an item on the agenda of a public meeting a consideration of the conditions of the jail, the number of deaths of prisoners in the jail and the known circumstances surrounding any such deaths during the immediately preceding six months. There were no prisoner deaths in the jail in the immediately preceding six months.

Staff Summary: A child care facility use is currently permitted in the RO use district as a conditional use accessory to a primary residential use. The Boys and Girls Club ("Applicant") is proposing an amendment to the RO use district, CCMC 18.04.110, to permit a child care facility use as a conditional use in the RO use district without being accessory to a residential use. A special use permit ("SUP") will still be required for a child care facility use in the RO use district. Per CCMC 18.02.075, the Planning Commission conducts a public hearing and makes a recommendation to the Board of Supervisors ("Board") regarding the requested zoning text amendment. The Board is authorized to amend the CCMC. Pursuant to Nevada Revised Statutes ("NRS") Chapter 237, a business impact statement is not required to be prepared with this ordinance.
